

# **SAFEGUARDING CHILDREN AT MOORWELL MIRACLES**



Moorwell Miracles Children's Nursery takes safeguarding matters very seriously and does all it can to protect its children from harm, abuse, and neglect.

### WHAT IS SAFEGUARDING?

Safeguarding is the action that is taken to promote the welfare of children and protect them from harm.

Safeguarding means:

- Protecting children from abuse and maltreatment.
- Preventing harm to child's health or development. •
- Ensuring children grow up with the provision of safe and effective care.
- Taking action to enable all children and young people to have the best outcomes.

## WHAT WILL HAPPEN IF A PRACTITONER HAS A CONCERN ABOUT MY CHILD?

Working under the Working Together to Safeguard Children (GOV UK) document, all members of staff have a duty to respond if they have a concern about a child.

What steps do we take?

- 1. Practitioners will record any injuries or conversations with a child/family member accurately.
- 2. Practitioners will discuss and disclose this information to the DSL immediately.
- 3. The information gathered will be shared with the child's parent or carer.
- 4. If the injury or disclosure if identified as significant (harmful or child at risk), the Designated Safeguarding Lead (Olivia) will report/discuss the concern with appropriate professional services.

This will not be done before speaking to the child's parent/carer unless this would put the child at risk of further harm.
